



## Sycom Property Fund (South Africa): Constituent Deletion FTSE/JSE Africa Index Series

The offer by Acucap Properties Ltd (South Africa, constituent) to acquire the remaining shares in Sycom Property Fund (South Africa, constituent) has now closed. Accepting shareholders received a Sycom Participatory Receipt in exchange for each Sycom Property Fund share held.
