DESCRIPTION	COMPONENT
Order rejection on last trading day	Frontend
Partially filled orders erroneously deleted on spreads	
instead of being updated	Frontend
Incorrect accumulation – Two strikes	Frontend

The following scenarios are needed for the following:

- Last trading day passed rejection
 - o Place an order on contract that's passed last trading day
 - o Confirm that order was rejected successfully
- Partially filled orders erroneously deleted on spreads instead of being updated
 - o Submit an order and partially fill the order
 - o Validate that the order remains active with updated remaining quantity
- Incorrect accumulation Two strikes
 - Accumulate trades on different contracts
 - o Confirm that accumulate rejected with error message
