The upcoming release will include a version upgrade of the Trading and Information system as well as deployment of various ITaC spillover items.

Required Client Engagement

Work is currently underway towards implementing the upgrade, which is targeted for Q3 2020. Please note that this is subject to market readiness and any major issues that may arise. We anticipate that client participation will be required between April and July 2020 for testing. Dress rehearsals will not be mandatory, however, comprehensive testing is strongly recommended to ensure a successful implementation.

The estimated high-level upgrade timelines are as follows:

- Software Provider Dress Rehearsal targeted for 9 May 2020
- 1st Market Facing Dress Rehearsal targeted for 20 June 2020
- 2nd Market Facing Dress Rehearsal targeted for 11 July 2020
- Go Live targeted for 25 July 2020
