MARKET VOLATILITY & SYSTEM MANAGEMENT OF HIGH VOLUMES

Considering the current volatile market conditions the JSE is taking pro-active measures to ensure that all systems and markets are operating fairly and efficiently.

Some of the checks being conducted daily are:

- Review of risk margin parameters
- Valuation checks and balances prior to end of day
- More frequent system performance checks
- · More stringent market surveillance and monitoring
- Ensuring that all systems have sufficient capacity from both an application and infrastructure perspective

The volatile market conditions has also resulted in extremely high volumes of live market data being published at times across all markets. We urge all affected clients to ensure that they cater for sufficient capacity from a bandwidth and storage perspectives to deal with the volumes.

N.B: The JSE Equity Derivatives are currently in consultation with the market regarding the price bands on the DCAP and DTOP instruments. An update will be provided by close of business on Friday, 13 March 2020.
