UPDATE - MARKET VOLATILITY & SYSTEM MANAGEMENT OF HIGH VOLUMES – CIRCUIT BREAKERS AND AUCTIONS

As an update to Service Hotline 052/2020, published 12 March 2020, with regards to the recent market volatility and high volumes, clients are reminded of the Circuit Breakers in place for the Equity and Equity Derivative Markets.

Circuit Breakers are defined as a percentage in relation to the Static Reference Price (Previous Day's closing price) and Dynamic Reference Price (Last Traded Price). If the Static or Dynamic circuit breaker for the relevant trading session is breached, the instrument will automatically be moved into a Volatility Auction Call session. The duration of the Volatility Auction Call Session is **5 minutes** for the Equity Market and **2 minutes** for the Equity Derivatives Market.
