INTEGRATED TRADING AND CLEARING (ITaC) REAL-TIME CLEARING (RTC) CUSTOMER TEST SERVICE (CTS) UPGRADE 19-22 JANUARY 2018

Clients are advised that the ITaC Real-time Clearing Customer Test Service (CTS) environment will be upgraded this coming weekend. The upgrade to the environment will commence on Friday, 19 January 2018 and be completed by end of day on Monday, 22 January 2018. The environment will therefore not be available to clients during this time. Normal service for Real-time Clearing CTS will resume on Tuesday, 23 January 2018.

The ITaC **Trading Customer Test Services (CTS)** for both the Equity and Derivatives markets **will not be impacted**.

The Real-time Clearing system upgrade includes the following:

- Operating system and database environment upgrades to the latest versions to ensure alignment to the planned production versions
- Clearing system software upgrade to the latest RTC Release 1.21 version which addresses the following issues as raised by clients:
 - Sequence numbers on the settlement event flow all being zero
 - o Adding a member client
 - o Duplication of sub-accounts
 - o Sequence number on start-of-day (SOD) positions
