JSE TRADING AND INFORMATION SYSTEM UPGRADE – MARKET FACING DRESS REHEARSAL

This notice relates to Service Hotline 020/2020 sent on 3 February 2020 and serves to remind market participants of the estimated high-level upgrade timelines as previously communicated:

- Software Provider Dress Rehearsal targeted for 9 May 2020
- 1st Market Facing Dress Rehearsal targeted for 20 June 2020
- 2nd Market Facing Dress Rehearsal targeted for 11 July 2020
- Go Live targeted for 25 July 2020

Please note that this is subject to market readiness and any major issues that may arise. We anticipate that client participation will be required between April and July 2020 for testing.

A reminder that the upcoming release will include a version upgrade of the Trading and Information system as well as deployment of various ITaC spillover items.

Though initial market communication indicated that dress rehearsals would not be mandatory, however, to ensure market readiness and a successful implementation, the 2nd Market Facing Dress Rehearsal, scheduled for 11 July 2020 will be **mandatory for all Trading Members and Information Subscribers**.

There will be no formal test structure or pass/fail criteria rather a dress rehearsal guideline for recommended testing. The JSE strongly recommends members perform comprehensive testing to ensure they are able to perform their daily trading activities.
