STT TECHNICAL UPGRADE | MANDATORY DRESS REHEARSAL

Further to <u>Service Hotline 074/2023</u>, market participants are reminded of the **second** STT Technical Upgrade Dress Rehearsal for the Commodity Derivatives, Interest Rate Derivatives and Cash Bonds Markets on **Saturday**, **8 July 2023**.

Trading Members, Information subscribers & software vendors:

Market participants are required to participate in the regression testing taking place in the Customer Test Environment from 4 July 2023 to prove functionality prior to the Dress Rehearsal.

Some key points to consider:

- Market participants are mandated to test in one of the scheduled MDR's to ensure a successful implementation.
- ➢ It is mandatory for ALL CDM Trading Members to participate in the upcoming dress rehearsal.
- The IRD and Cash Bond Trading Members who did not participate in the 10 June 2023 dress rehearsal are mandated to connect, perform trading activities and sign-off on 8 July 2023.
- No results will be issued post regression testing and dress rehearsals, but we rely on your teams to ensure adequate testing and sign-off as an indication of a successful test.

Sign off and Communication Requirements for Trading Members and Trading software providers:

The compliance officer is required to confirm readiness by 12 July 2023, for go-live to irc@jse.co.za and commodities@jse.co.za upon successful completion of the dress rehearsal.

Sign off and Communication Requirements for Real Time Information Subscribers:

You are required to confirm go-live readiness by 12 July 2023, for go-live to MDProducts@jse.co.za upon successful completion of the dress rehearsal.

Clearing Members:

- > Clearing Members are mandated to participate in the upcoming dress rehearsal on 8 July 2023. Clearing members will be required to test the following during the dress rehearsal:
 - Connectivity from their production environment (Clearing Members may disconnect from their production environment for the remainder of the test, if they foresee any issues with rolling back their production environments post the dress rehearsal).
 - o Reference data download (Prior to main activities).
 - o Deal management activities performed on behalf of their members.
 - Confirmation of trade data feed to their systems.
 - Monitoring of position updates.
 - Perform on-behalf-of trades.
 - o Participate in end of day activities (no balancing required).

NB: If any issues are experienced on the day please report them to CSC during the dress rehearsal on Saturday, 8 July 2023.

Sign off and Communication Requirements (Clearing Members):

- > To ensure you receive SMS communication, clients are reminded to provide mobile numbers for person/s testing during regression testing and dress rehearsals.
- > A reminder to provide contact name, email address and mobile number for person/s responsible for sign off as per the signoff sheets provided in the Clearing member testing guide.
- Please provide the above to ClearOps@jse.co.za as soon as possible.
- > You are required to confirm go-live readiness to ClearOps@jse.co.za upon successful completion of dress rehearsals and regression testing.
