RE-PLATFORMING OF MEMBER RANKING REPORTS

The JSE's strategic plan for data product delivery incorporates leveraging modern data technologies, maintaining effective security controls, simplifying the product and licensing landscape, and ensuring equal treatment for all customers. In line with this strategy, we are informing you via this Service Hotline of upcoming changes to the way that member ranking reports in the Equity Market can be accessed.

The following changes will be effective from 1 January 2024:

- Member ranking reports will no longer be delivered by e-mail
- The differentiated BIR/BDR/BXR/combo fee structure¹ will be collapsed into a single license option
- The daily/weekly/monthly subscription option will be collapsed into a single license option

The delivery of these confidential member ranking reports for the Equity Market will move to the JSE's new Trade Explorer platform, with a new Basic subscription option being introduced to cater for this use case. Any clients with an existing Pro subscription to Trade Explorer will have access to these reports at no additional cost. The JSE believes that the following benefits will be realised by this change:

- Shifting from the legacy technology platform that currently generates these reports will improve the security posture of this service.
- Removal of the e-mail delivery option and addresses management processes reduces the risk of data incidents.
- Significant simplification of the pricing and licensing options.
- Self-service capability for clients to access the data on demand for any custom time period.
- No change to file format means no impact to systematic processing.

Members utilising the existing reports will not be automatically transitioned to the new solution and will be required to opt-in for subscription to the JSE Trade Explorer Basic license. Our team will be engaging with current subscribers of the member ranking reports to showcase the JSE Trade Explorer base package features, commercials and to ensure that the transition is as seamless as possible for those subscribers who wish to take up the new service.
