Additional Johannesburg T+3 Phase 3 Training

Due to the overwhelming response to the first phase of T+3 training in Johannesburg, we have decided to extend the training schedule by a further three days to accommodate additional trainees.

The training has been organised to assist members in their preparation for Systems Integration Testing (SIT) and User Acceptance Testing (UAT), and is aimed at Compliance Officers, Settlement Officers and any other interested back-office Broker staff.

The intention of the training is to ensure that all persons are educated and aware of the system and process changes that will take place as part of the move to a T+3 settlement cycle.

Additional Training Timing (Phase 1)

The additional training will take place from the 8th – 10th February 2016 and will be split over two sessions per day.
