Clients are advised that there have been 2 volatility auctions triggered on instrument GFI at 12:10 and 12:18 respectively.

When a circuit breaker is triggered, it then results in a volatility auction period for an initial period of 5 minutes. Thereafter the instrument returns to Continuous trading and orders residing on the order book post the volatility auction based on the Price/Visibility/Time priority, if not amended or cancelled, will then match.

In the case of GFI the following occurred:

- 12:10 Static circuit breaker was triggered; price was more than 10% away from the opening price. (Opening Price = 24495)
- 12:18 Static circuit breaker triggered, more than 10% away from last traded price. (Static reference = 28625)
