- Delayed dissemination
- Limited technical and financial support

As part of our ongoing journey to modernise how we make market data available to clients, we have launched a [Marketplace](#) platform, a digital platform that enables clients to subscribe to our data products.

To address the current challenges and to provide more value to you, we are excited to introduce a new suite of enhanced Equity Non-Resident data products that are available exclusively via the [Marketplace](#) namely:

- **Equity Non-Resident by Alpha** - contains trading activity by non-residents, JSE total value traded and the foreign participation rate at an instrument level. This product provides insight into non-resident participation per Alpha.
- **Equity Non-Resident by Market** - provides a daily aggregated summary, including non-resident trading, total JSE Value Traded and the Foreign Participation rate at the JSE. This product provides insight into daily foreign participation at market level.
- **Equity Non-Resident Statistics Restated** - provides all non-resident statistical data including trade and statistics dates.
  - This product is aimed at a client that wants to maintain a historical database containing certain equity non-resident statistics.
