- Successfully view market data and receive live updates during the test to ensure public data is processing
- Cancel a trade
- Deal management

Clearing members:

- Confirm reference data is viable on the front-end OR re-request start of day reference data via the API
- Perform downloads, run End of Day activities and verify balances
- Perform Off Book Trade Reports for each client
- Deal management
