JSE TRADING AND INFORMATION SYSTEM UPGRADE – END-TO-END TESTING ENVIRONMENT FOR TRADING AND CLEARING MEMBERS

The JSE refers to Service Hotline 089/2020 issued on 9 April 2020 and would like to inform market participants that the End-to-End (ETE) Test environment for the JSE Trading Upgrade 2020 will be available for clients from Tuesday, 2 June 2020.

Clients are urged to make use of the ETE test environment to test their trading solutions and internal day-to-day business processes in this environment to ensure that all daily business functionality is tested prior to go-live.

The JSE would like to remind clients that the upcoming release will include a version upgrade of the Trading and Information system as well as deployment of various ITaC spillover items. *Members are advised to engage with their Software Providers to confirm impacts to their Trading frontend/solutions as well as testing capabilities available to them.*

Non-Live Market Data will be out of scope for ETE testing as there are no changes to dissemination and data products.

The test approach will be unscripted but will include scheduled testing events e.g. Futures Close-out and Month End. The detailed test plan will be communicated shortly.

Please note: The RTC Application version available in the ETE environment is version 1.32 which includes functional changes but no API interface changes (refer to Service Hotline 123/2020). This version has been successfully tested with the current production version of the treading engine (go live of RTC 1.32 scheduled for 15 June 2020) and we require customers to verify and test compatibility with the upgraded trading engine scheduled for July 2020 in this phase of testing.
