# RTC 1.34 UPGRADE - DRESS REHEARSAL SCHEDULE & REQUIREMENTS 17 JULY 2021

Clients are reminded of the Real-time Clearing (RTC) Upgrade Market Facing Dress Rehearsal scheduled in the production environment on Saturday, 17 July 2021.

The Dress Rehearsal is mandatory for clients who did not participate on 10 July 2021 or for clients who would like to retest to provide sign-off.

Clients who tested on 10 July 2021 and has provided sign-off will not be required to test on the 17 July 2021.

Please use the attached trading schedule and test guide as a guideline for recommended testing, and, whilst there isn't a pass/fail criterion, we recommend comprehensive testing to ensure successful ability to perform daily activities.

## RTC DEPOLYMENT & EARLY SHUTDOWN - 16 JULY 2021:

- We will deploy version 1.33 and 1.34 of the Real Time Clearing system on the evening of Friday, 16 July 2021;
- To ensure this deployment is completed in time for dress rehearsal activities, RTC production will go offline as soon as end of day activities with clearing members have been completed on the evening of 16 July 2021;
- The JSE aims to have RTC available from 09h00 on 17 July 2021 for testing.

Clients not participating must ensure production systems are **shut down** prior to the systems startup (preferably the evening before the scheduled change), to not receive and process any test data

Recommended Testing	Trading Members: Encouraged to test all relevant Deal Management functions and any other applicable functions to prove daily activities and processes.
	Clearing Members: Encouraged to test all relevant On-Behalf Of Deal Management functions, and any other applicable functions to prove daily operational activities.  Run EOD and balance to the JSE on CM1 and CM2 on commissions.

The targeted go-live is 31 July 2021 subject to market readiness and any major issues that may arise. Thank you for your participation to ensure a successful implementation.
