#	Main issues experienced	Status	Details
1	JSE Website	Resolved	The JSE experienced recovery challenges with its primary website which was subsequently restored.
2	Connectivity	Resolved	Some clients were unable to connect to the Disaster Recovery site due to their network providers experiencing network outages.
3	Telephony	Resolved	The JSE experienced telephony challenges on the day of Disaster Recovery and Business Continuity test. These included connectivity and latency issues which were resolved.
