BDA AND COLLATERAL MANAGEMENET WITH STRATE'S COLLATERAL MANAGEMENT SYSTEM

BDA has been enhanced to cater for the movement of securities from the brokers Proprietary Custody Account to the brokers Collateral Giver SDA (Segregated Depository Account) at their CSDP which will enable the securities to be managed in Strate's Collateral Management System.

The new BDA on-line functions will be activated over the weekend of 16 September 2017 on completion of a successful cycle of integrated testing with the ITAC project.

The functionality allows for the transfer of security holdings from the Custody Account to the SDA and from the SDA back to the Custody Account and the resultant accounting entries to reflect these movements. SWIFT account transfer messages (MT540 and MT542) will be automatically generated so that the transfer can be actioned by the CSDPs through Strate.

Securities can be pledged or ceded to counterparties during the day on the Strate Collateral Management System however; BDA will receive a SWIFT statement MT569 message as part of the end of day batch process which is used to update BDA to reflect the status as at the end of day. Corporate Actions will be processed on the MB (Member Balance), MC (Member Cession) and MP (Member Pledge) holdings in BDA.

A daily reconciliation is performed between the BDA SDA balance and the Collateral Giver SDA as well as the BDA Proprietary Custody balance and Proprietary Custody accounts at the CSDP by means of the SWIFT Statement of Holdings MT535 messages and any discrepancies will be highlighted on the Proprietary Reconciliation PCSDRP report.
