## JSE TRADING AND INFORMATION SYSTEM UPGRADE - RELEASE 7.6

Clients are advised that the latest release (7.6) to the Millennium IT Trading and Market Data system will be delivered on 20 November 2023.

The release will include the solution to the issue related IOC orders submitted during the CPX session, which was highlighted in service hotlines <u>077/2023</u>, <u>085/2023</u>, <u>155/2023</u>, <u>162/2023</u>

Please take note of the summary of the issue being addressed in the release:

- The CPX (Closing Price Cross) is a session after the closing price of an instrument has been determined allowing extended trading only at the instrument's closing price.
- Currently, certain order types are rejected during CPX session i.e., IOC with the error 'Invalid TIF (Pending closing price for trading).
- The fix to ensure that IOC orders are accepted and subsequently can trade during the CPX session will be applied with Release 7.6.
- Additionally: no orders will be deleted; the order books will remain the same on Monday (20 November 2023) morning as close of business on Friday (17 November 2023).

This release has no API changes; therefore testing is not mandatory. However, testing in the CTS Release environment is encouraged. The latest version of the code is currently available in CTS Release.
