UPDATED POST TRADE SERVICES DOCUMENTATION AND CTS ENVIRONMENT FOR THE INTEGRATED TRADING AND CLEARING (ITaC) PROJECT

Clients are advised that the ITaC Post-trade Customer Test Service (CTS) environment will be upgraded to RTC Release 1.20 on **Saturday, 14 October 2017**.

RTC Release 1.20 addresses the following issues as raised by clients:

- TaxReplayReq event (Message ID 232) not working according to specification
- Partial assign functionality not functioning as expected

The Post-trade CTS environment will therefore be down for maintenance on Saturday, 14 October 2017. Normal service for Post-trade CTS will resume on Monday, 16 October 2017.

In addition, clients are advised that minor clarifications and cosmetic updates have been made to the ITaC Post-trade Services Documentation and are now available for download.
