Clients are advised that the **Real-Time Clearing documentation** for the upgrade to **RTC Release 1.34.0** is now available.

The dates for the CTS and Staging (ETE) environment upgrade and the production upgrade timelines for this version will be advised shortly but are expected to be Q4 for test system availability with a go live in Q1 2021.
