# INTEGRATED TRADING AND CLEARING (ITaC) PROJECT - UPDATED INSTRUMENT REFERENCE DATA GUIDE

Clients are advised that the ITaC Instrument Reference Data Guide has been updated and is now available for download. This document explains the Instrument reference data standards and changes being introduced as part of the ITaC project.

An issue was raised by clients during the 6 October 2018 dress rehearsal related to the Instrument Reference Data files. The query was regarding duplicate Contract Codes on MXWD. See sample data below:
