Clients are advised that updates to the ITaC Post-trade Services Documentation have been published and are now available for download. These documents form part of the JSE Services Documentation.

Post-trade Services Documentation includes the deal management and clearing/settlement functionality available for the ITaC Project 1b (Equity Derivatives) and ITaC Project 1c (Currency Derivatives) markets when they migrate to the new Post-trade real time clearing and settlement system. Documents have been updated using tracked changes so that clients can easily identify the changes.

To align to the updated specification documents issued, clients are advised that the Post-trade Client Test Service (CTS) environment is being upgraded to RTC Release 1.15.0. This is a cumulative upgrade which includes RTC 1.14.0:
