ITaC Guidance Note for Decommissioning Testing.pdf	New	As part of the Integrated Trading and Clearing (ITaC) project, the Equity Derivatives and Currency Derivatives markets will be migrated from the Nutron trading platform onto the new Integrated Trading and Clearing (ITaC) technology. As such, they will no longer be accessible on Nutron post ITaC go live. The purpose of this guidance note is to highlight the decommissioning testing necessary to prove that the migration is successful.
