# INTEGRATED TRADING AND CLEARING (ITaC) END-TO-END FINAL TESTING CYCLE DOCUMENTATION NOW AVAILABLE

Clients are reminded of the start of the scripted ITaC End-To-End Final testing Cycle which is scheduled from Monday, 14 January 2019 – Friday, 1 February 2019. This is the final scripted testing cycle available to clients prior to the scheduled go live on Monday, 8 April 2019. The ETE environment will not be available from 24 December 2018 - 12 January 2019 which is the project break and environment data refresh period.

A **key objective** during this **ETE Final Testing Cycle** with clients (trading members, asset managers and clearing members) is end to end testing of commissions management, reporting and processing. A specific sub-focus of this commission testing is the testing of 'Adhoc' commissions. Adhoc commissions are commission entries which do not require a reference to a specific deal. They can be used for bulk commissions i.e. a commission charged to a client for execution of multiple trades or to affect a commission adjustment for an erroneous commission from a previous day. Adhoc commissions feed into aggregate (net) commission amounts but will not appear against a specific deal in deal-level EOD reports from Clearing Members i.e. Adhoc commissions are reported and processed on the account level
