# ALERT ABOUT INCORRECT STATISTICS IN END OF DAY EQUITY DATA FILES FOR TUESDAY, 10 MARCH 2015 - UPDATE

The JSE would like to provide client with an update on the Statistics problem that arose from the technical problems on Tuesday night. The problem lead to a number of statistics based data fields being incorrect in the data files that are provided at the end of each day.

The JSE has unfortunately not been able to address the problem. Addressing the problem has got the highest focus at the JSE.

This means that a number of data fields provided in the Late Equity (E file) as a number of data fields (related to value add records) provided in the Indices data file (I file) will still be incorrect for tonight.

The fields in question are as per below, and the impact to your company will depend on the type of data records that you subscribe, and the use of the data fields in your subscribed records.
