TRANSFER OF TAX FREE SAVINGS ACCOUNTS

With effect from 1 March 2017 it will be possible to transfer Tax Free Savings Accounts from one member to another. The details of the transfer need to be reported to SARS and the member transferring the account must issue the Investor and the receiving member with a Transfer Certificate.

Dematerialised Holdings

With regards to the transfer of the securities it would be best if the Account Transfer or Portfolio Move functionality in BDA is used for demat holdings. When reporting to SARS, a combination of the Transaction Code (I1 or I2, E1 or E2 and P1 or P2) and the TFSA flag will be used to determine if a dematerialised holding was transferred to or from another account or broker, so the correct ITS Source Codes can be populated.

Cash

For the Cash portion of the transfer two new Designation Codes have been added to the T.DES table. These codes must be manually entered when recording a Cash Payment (T2) or a Cash Receipt (T3) when transferring the funds of a Tax Free Savings Account. These codes together with the TFSA indicator will be used to populate the correct ITS Source Codes.

The two new designation codes are:

- o T2 TFSA CASH TRF OUT
- O T3 TFSA CASH TRF IN

The relative section of the T.DES table is displayed overleaf.
