### INTEGRATED TRADING AND CLEARING (ITaC) REAL-TIME CLEARING (RTC) CUSTOMER TEST SERVICE (CTS) UPGRADE 5 MARCH 2018

Clients are advised that the **ITaC Real-time Clearing** Customer Test Service (CTS) environment will be upgraded on Monday, 5 March 2018 between 06h00 and 08h30. The environment **will therefore not be available** during these times. **Normal service for Real-time Clearing CTS** will resume thereafter.

The **ITaC Trading** Customer Test Services (CTS) for both the Equity and Derivatives markets **will not be impacted**.

The Real-time Clearing system will be upgraded to the latest RTC Release 1.22 version which addresses the following issues as raised by clients:

- The AddCommsionReq message has been updated to allow commissions to be added to a TM or Branch. Descriptions will be added to the message in the API for more clarity.
