### **CHANGE OF GO-LIVE TO MONDAY, 3 MAY 2021 OF NEW MARKET DATA PORTAL AND DISCONTINUATION OF CURRENT JSE MARKET DATA PORTAL**

We previously notified you that we will be providing you with enhanced functionality and a more enriched self-service experience through the introduction of a new Market Data Connect portal, provided and hosted by DataBP an international provider of market data administration solutions. If you want to know more about this initiative, please refer to the attached information session presentation.

We clarified that phase 1 only affects clients that have a data agreement obligation to report data usage numbers and/or Indices tracking numbers as well as those clients that maintain Indices Valuations, Tracker and Constituent data (VCT) end user numbers. All this currently being done via the JSE Market Data Portal (MDP) or, for a small set of approved clients, via a monthly data file provided to the JSE.

Phase 1 will shift all reporting to the new portal and JSE MDP will be discontinued. While VCT customers will be able to see their end user numbers through the new portal in phase 1, the ability to change them will come in phase 2, and so the MD team will assist with VCT changes in the period between phases 1 and 2.

**While the JSE had targeted Thursday, 1 April 2021 for phase 1 go-live for the introduction of the new portal and discontinuing MDP and provision of data files to the JSE we have decided, in the interest of giving all impacted reporting clients more time to log on to the demo environment and get familiar with the new solution, to extend the phase 1 go-live to Monday, 3 May 2021. So reporting for April must still continue via the current methods which includes using the current JSE MDP.** This extension will also allow the project team JSE to make sure that all necessary go-live preparation actions are complete and checked.

If you are a reporting client and your designated reporting person has not yet registered and logged on to the demo environment and tested by submitted a test report, please ensure that this takes place in the extended period. The demo environment is available via the following link and registration must be done using the email address used for MDP reporting.
