### Introduction of new JSE TradElect Trading Segments and Sectors

Further to Service Hotline TS 2011/17 issued 31 May 2011, the JSE would like to advise all JSE TradElect and InfoWiz clients of the scheduled Market Structure review changes as detailed below.

As part of the JSE's ongoing Market Structure review, the following changes were applied in the CDS environment on 1 June 2011. The JSE hereby notifies clients that these new Segments and Sectors will go live into the production environment with effect from Monday, 28 November 2011.

### 1. Introduction of New JSE Segment: ZA06
