## Objection to Kameel as Soya delivery point

Further to Market Notice 323/2015 where Suidwes Landbou (Pty) Ltd (Registration Number 1990/006879/07) had applied to register Kameel as a soya delivery point, the JSE has received objection from the market, citing the following concerns:

- 1. Soya bean production in this area is very limited and the concern is that the limited production will result in a distortion of the overall reference price for soya beans traded on the JSE;
- 2. The said delivery point is located far from the general processors. This therefore implies the transport costs will be substantially more expensive in relation to the other delivery points;

Based on this SWL Kameel is **NOT** going to be registered as a JSE soya delivery point.
