Please be informed that new Average Daily Value Traded (ADVT) and 1-day VAR parameters will be implemented on **Wednesday, 30 July 2025**.

ADVT and 1-day VAR are inputs in the JSE Clear Margin Methodology, used in the calculation of the Liquidation Period Add-on margin.

The approved change in the maximum participation assumption (MPA) from 33.3% of ADVT to 25% of ADVT will also be implemented on **Wednesday, 30 July 2025**. This is an input into the Liquidation Period Add-on margin calculation.
