Please be informed that new initial margin parameters for the Equity Derivative and Currency Derivative markets to be implemented on **Tuesday, 14 January 2025**, can be found at this directory:

The settlement margin requirement (SMR) on physically delivered contracts will be updated. The SMR per contract will be computed as the initial margin requirement divided by contract size.
