Please be informed that Single Stock Futures (SSFs), DCAR Index and DTOR Index spread series margin requirements (SSMRs) for the Equity Derivatives market have been recalibrated and will be implemented on Monday , 19 June 2023 .	
The Series Spread Margin Requirement (SSMR) parameter determines the amount of margin offset between instruments whose CSGs are linked to the same Series Spread Group (SSG).	
This annual update will result in an estimated 0.33% overall increase in margin across the market.
