Please be informed that new initial margin parameters for the Equity Derivative and Currency Derivative markets to be implemented on **Tuesday, 8 October 2024**, can be found at this directory:

The settlement margin requirement (SMR) on physically delivered contracts will be updated. The SMR per contract will be computed as the initial margin requirement divided by contract size.

The Cando IMRs will be updated on 9 October 2024.
