Members notice is drawn to section 13 of the contract specifications of Individual Equity Futures and options, which states:

### “13. Corporate Events

The JSE reserves the right to adopt any procedure or to adjust any single stock future or option on a single stock future, in a manner it deems fit, to deal with any extraordinary corporate events that may occur from time to time in relation to a share that is the underlying instrument of the equity option and to notify position holders, derivatives members and any other interested parties, of such event and the procedure or adjustment adopted. Such events include, for example, mergers, take-overs, unbundlings, capitalisation issues and rights issues.

The implication of this is that anybody trading in Single Stock futures or options on Single Stock futures in which the underlying stock is the subject of an extraordinary corporate event should be aware that the JSE may make adjustments to the Single Stock futures and options.

### Consolidation

**AMC Entertainment Holdings Inc (AMCI)**, shares will be consolidated on a **10 for 1** basis. With regards to this corporate action, the following adjustments will be made to AMCI positions on 24 August 2023 (**Ex-date**). The adjustments will be made to the positions held as at close of business on 23 August 2023 (**LDT**).

Adjustments will be made to all contracts where AMCI is the underlying share. These contracts include:

**Position adjustments on Futures**

- The positions on futures will be closed and new adjusted positions will be opened by applying the position factor formula
- Position factor formula = Resultant (1)/Source (10)

Position on LDT: + 10 18SEP23 AMCI CSH DN

Position on Ex Date: + 1 18SEP23 AMCI CSH DN

**TREATMENT FOR ALLOCATION ON ADDITIONAL CONTRACTS**
