SUBJECT: CHANGES TO SERIES SPREAD MARGIN REQUIREMENTS FOR EQUITY DERIVATIVE MARKETS

Dear JSE Stakeholder

Please be informed that series spread margin requirements (SSMRs) for the Equity Derivatives market international indices and sector-based margin offset groups have been calibrated and implementation commenced from the 15 August 2022 Market Notice 391/2022. This implementation is being performed in a phased approach. The next groups for implementation are Real Estate, Consumer Cyclical and Consumer Non-Cyclical with the offset being effective for margins as at EOD 12 September 2022.

The series spread margin requirement (SSMRs) parameter determines the amount of margin offset across contracts in different single names within a common class spread group:
