Dear Stakeholder,

JSE, with the support of the Agricultural Advisory Committee, has decided to move the first position day for physically settled grain contracts to 4 business days preceding the first business day of the expiry month. The change emanated from a request from members to remove daily price limits on the physically settled contracts earlier, this will afford participants the day after option expiry to trade out of positions without the risk of locking in at the published price limit.

Please could members inform their clients that price limits for the spot month will therefore be removed earlier than before, please refer to the published "first position day" dates.
