Request for information to assist with the determination of location differentials for sunflower seed and the maize futures contract for the 2011/2012 marketing season

The new marketing season for the above commodities is approaching and we kindly request all interested parties to provide their input in order to ensure the published differentials most accurately reflect transport costs from the registered delivery point to Randfontein.

All interested parties are invited to provide indicative road and/or rail rates that are currently applicable or will be as from 1 May 2011. The format in which the transport rates are provided may be specific to each individual silo or could be indicated as a percentage change (increase or decrease) from the current published rates.

It would be especially useful to receive road rates for the following road only access delivery points as the final location differential is adjusted based on actual road rates received:
