Request for information to assist with the calculation of wheat Location Differentials (LDs) for 2013/14 marketing season

Please feel free to distribute to any interested parties.

The new marketing season for wheat is fast approaching and we kindly request all interested participants to provide input in order to ensure the published location differentials most accurately reflect the cost of transport from the registered delivery point to Randfontein.

As per previous years, all interested parties are invited to provide indicative road rates that are currently applicable. Since improving the process in calculating the location differentials as per notice A1674, please provide indicative road rates in the following format considering rates as at early August 2013:

Once information is received as per table above, we will then proceed and use the formula below to determine rand per ton (RPT):

$$RPT = \frac{Distance * RLF * RPK}{Payload}$$

Where:

Distance is distance in km to the reference point,

RLF is the return load factor,

RPK is Rand per km, and

Payload is in tons.

We will continue to treat the Western Cape silos registered as delivery points on the Randfontein contract as a special case. Hence the above formula will not apply when determining the wheat location differentials for these silos and we will instead rely on a market survey of actual road rates.

Indicative **rail rates** to Randfontein will also be required for the final calculation and so these are also kindly requested to the email address below.

Regarding gathering information in terms of rail vs road out-loading ratio for the previous year, this will be requested directly from each registered storage operator and this information will also be used as input in the model to determine the LDs.

It is also imperative market participants refer to the published distances of each registered delivery point to Randfontein to ensure these remain accurate as the distance travelled is critical in ensuring the accuracy of the calculation. The distances can be found in this file under the sheet "Distances and capacities"
