Dear Stakeholder

The JSE would like to thank everyone for participating in the Market Dress Rehearsal on 25 February 2012.

Unfortunately and regrettably, it was decided on Saturday, the Dress Rehearsal and subsequent go-live was unsuccessful. We have tabled the list of issues that were encountered during this weekend's testing and have begun investigating the root cause and resolutions thereof.

The following issues were reported by the market participants:

Functional / Front end Problems

Issue No.	Problem	Resolution
1	Branch members orders in the public order book were shown under the main member's public order book identifier. This resulted in branch members not seeing their own orders marked with an X in the public depth	The issue has been identified and will be resolved for the next dress rehearsal
2	User rights – some users did not have the correct subscription groups enabled for their dealer codes	This issue occurred in the first dress rehearsal as well and is being investigated
3	Report only deals from client to client results in the 2 nd leg still reflecting under the principal as the member	This issue is still under investigation
4	Members receiving identical EDM trade sequence numbers for two different deals	This issue is still under investigation

1	Trace deals download not returning any data	The problem has been identified and will be addressed.	The procedure used to retrieve the data had to be amended
2	Missing and/or duplicate login responses	This issue is still under investigation	Details will be provided once the cause of the issue has been established
3	Unique order and unmatched deals sequence numbers weren't catered for	This was a data conversion issue	A full audit data conversion will be done before any future dress rehearsal
