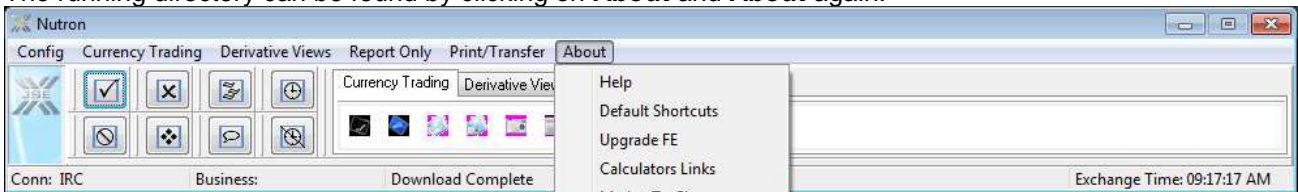
### Patch for booking of Currency Option deals on Nutron

Dear Stakeholder,

The JSE has identified an issue on the IRC NUTRON frontend whereby Currency Options deals that were initially booked with a premium of 4 decimals are rounded off to two decimals when performing an allocation or deal split.

We have provided a patch to resolve this issue. The file would need to be copied across into the running directory of Nutron.

The running directory can be found by clicking on **About** and **About** again:



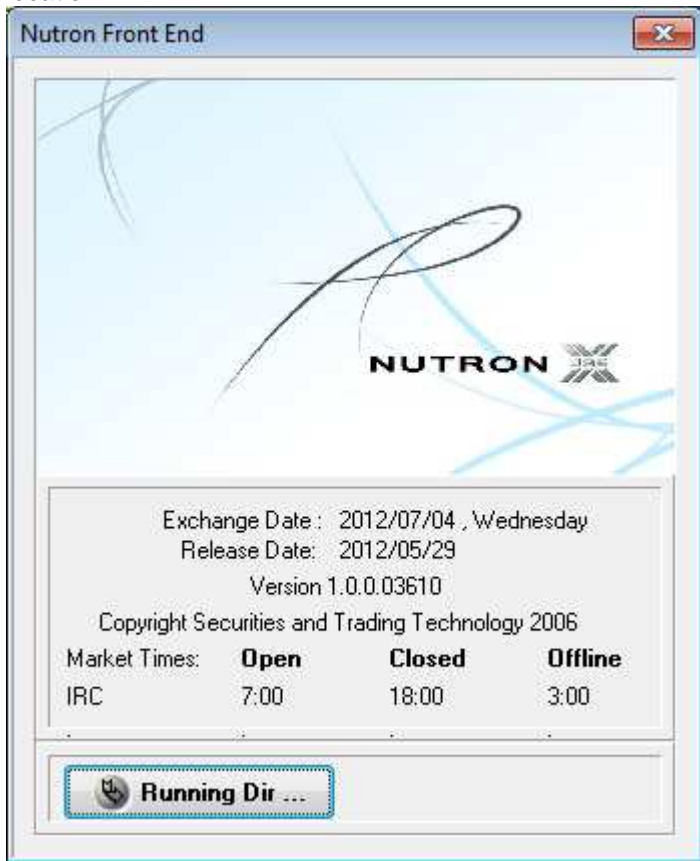

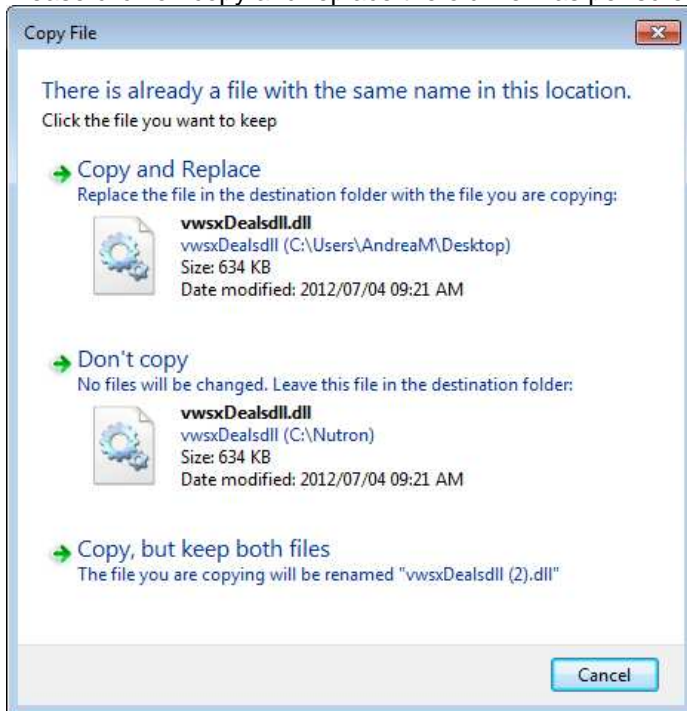
