- (b) a hypothetical USD floating rate deposit made with the Issuer on or about the Trade Date with inter alia the following terms: (i) the Effective Date of the deposit is the same as the Issue Date of these Notes; (ii) the Nominal Amount is USD1,430,950.90, and (iii) the repayment date of the deposit is the same as the Maturity Date of these Notes; and
- (c) any instruments held or transactions entered into by the Issuer in its sole discretion in order to hedge its obligations to the Noteholder under these Notes including, but not limited to, any fixed deposits and/or funding arrangements.

Where applicable, the underlying transactions set out above will be subject to the terms of the 2002 ISDA Master Agreement as published by the International Swaps and Derivatives Association, Inc. (including a Schedule thereto) concluded on the Issuer's standard terms.
