PROJECT STATUS UPDATE

- 16 Sept 2021
 - JSE announcement of our intention to embark on the replacement / rejuvenation of the SENS service
 - Key drivers for this was to address client pain points and the changing business and technology needs
- 16 Nov 2021
 - Project communication kick off session with all clients to outline the intended project scope and impact to the market
- 30 Nov & 2 Dec 2021
 - Consultation sessions with Sponsors and Designated Advisors to discuss in more detail the system change impacts
 - To solicit feedback on the structured data opportunities and aspirations
 - JSE team spent time unpacking the feedback received and the various technical considerations
- 6 Jul 2022
 - JSE communication to confirm a more conservative, iterative approach to implement system changes to mitigate operational risk
 - Revised scope for SENS Release 1 to replace the system front-end technology and integrated workflows
 - Input and Output formats to remain as is (for now), therefore no impact to market data subscribers in release 1
 - This allows us more time to consult the market further with regards to the current cost of processing corporate actions (CA survey in progress)
 - Further unpack the benefits, requirements and preferred technology for implementing structured data

 - 10 Nov JSE information session with Sponsors and Designated Advisors project status, external user testing, new system features, look and feel

PROJECT STATUS UPDATE

- Development of the new SENS front-end and related system workflows is progressing well
 - Announcement creation
 - My worklist
 - Announcement re-work
 - Announcement Dissemination and EOD Dissemination
 - Announcement notifications (normal and additional)
 - Announcement retraction and corrections
- Focus is to complete the client facing features first to prepare for client training and testing
- We will then address the remaining administration, audit and other internal features of the system
- Internal JSE business testing of the client facing features is also progressing well
- Initial phase of external user testing is under way
 - Received 10 volunteers to be part of the initial representative set of testers on behalf of Sponsors and Designated Advisors
 - We are delighted with their active and engaging participation received thus far relating to the system usability, features and functionality prior to broader market testing
- Consultation with Issuers on change impacts to their users

JSE will conduct a full SENS User Audit

- Users should not be sharing production login credentials all authorised Sponsor approvers and SENS submitters should have their own credentials
- Certain production SENS users have not logged into SENS for more two years and therefore their existing production user id will be deactivated on go live, unless they are authorised via the new user registration process prior to go live
- Start identifying the users within your company that require access and the roles they will need in production
- We are targeting mid-end February 2023 to start the take-on of new user registrations in our new pre-prod environment
- User connectivity and access will be tested and proven during market facing dress rehearsals

Current process is cumbersome and administration intensive

- Long standing Issuer and Sponsor pain point especially when out of office hours and there is a need for urgent announcements
- Considered Issuer approval for every announcement but that would be just as cumbersome

Dedicated and Transaction Sponsor maintenance when required

- Ability for Issuers to maintain transaction Sponsors as needed
- Effective From and To Date per Transaction Sponsor control access and the ability for a Sponsor to issue announcements on your behalf however, note changes are effective as a start of day
- Dedicated Sponsor maintenance will be dealt with by the JSE MDS via the standard listing requirements process

Sponsor information is stored within JSE systems

- Primary source of all company roles, contact details and linked Sponsors are the JSE Customer Relationship Management (CRM) and Master Data System (MDS)
- Ensure accurate information is maintained and used across various JSE systems

Enhanced security control

 Authorised SENS submitters of a Sponsor will only be able to select an Issuer that they are linked to as the Dedicated or Transaction Sponsor within JSE systems

SENS TOKEN PROCESS – AS IS



- A Registration Token
 - Allow the user to **apply for access** to the system
 - Every time an External User registers a new user, the system will prompt the user for a registration token
 - This registration token will be validated in the database against the company name

A SENS Submission Token

- Allows the user to perform **SENS Submissions**
- This token is a random number automatically generated by the system
- These tokens are generated for security purposes in order to ensure the authorisation of the user performing the submissions
- Users will not be able to create and submit SENS announcements if a valid SENS Submission Token has not been captured
- Every time an External User (excluding an Equity Issuer) submits a SENS announcement, the system will prompt the user for a SENS Submission Token
- This SENS Submission Token will be validated in the database against the company name
- A SENS Submission Token can only be **used once** and is linked to a specific company

NEW USER REGISTRATION – REMINDER OF NEW PROCESS

- Improved user profiles, additional access roles and system login authentication
- This replaces the current Registration Token process
 - 1. A new user will complete the online **New User Registration form** with a few basic details
 - 2. The 'User Access Administration' user will receive an email to approve the new user request on behalf of their company
 - 3. The 'User Access Administration' user will **login to the SENS system to approve / decline** the user request and confirm the roles required for the new user
 - 4. On **approval** by the 'User Access Administration' user, the new user will receive a **one-time link** to capture their personal details.
 - 5. Once submitted, the JSE user registration workflow will be triggered. The JSE teams will then complete the various technical enablement steps required for the new user
 - 6. On successful completion of the new user registration request an **email will be sent** to the new user with the SENS credentials as well as a **link to create a new password**
 - 7. The new user must click the password creation link to create their new password and enable their profile



TOKEN REPLACEMENT SOLUTION – ISSUER SPONSOR APPROVAL

- New Issuer approval of registered Sponsors and/or Designated Advisors
 - Issuers will need to ATTEST or DISPUTE the Dedicated Sponsors authorized to submit announcements on their behalf
 - The SENS system will only allow those Sponsors to submit announcements for the Issuer
 - Linked Sponsors displayed for attestation is data as available in JSE systems changes to dedicated Sponsor details are effective as at next day (i.e. start of day only)
 - To ensure audit compliance a regular confirmation/attestation of approved sponsors will be needed
 - In preparation for go live Issuers will perform this approval via the new online SENS front-end
 - If you Dispute a Sponsor this automatically alerts internal JSE teams and triggers an internal JSE process to resolve the dispute raised with the relevant Issuer / Sponsor. This process is outside of the SENS system
 - An automated system reminder will be sent to users with the "Issuer who can approve Sponsor Relationships" role based on the configured system parameter e.g. annually for Sponsor attestation to be redone. However, Issuers can at anytime conduct attestation via the front-end as per their needs e.g., quarterly
 - NB: Online approval of Sponsors via SENS does not replace obligations of Issuers / Sponsors / DAs to formally notify the Issuer Regulation team of Sponsor changes as per standard Listing Requirements process
 - Issuers will be able to maintain Transaction Sponsors to submit announcements on their behalf
 - Changes to Transaction Sponsor details via the front-end are real-time and immediately effective in the SENS system
 - Issuers can amend the Effective-From-Date and Effective-To-Date of a Transaction Sponsor as needed
 - In preparation for go live, Issuers will have the opportunity to load Transaction Sponsors if needed via the new online SENS front-end

TOKEN REPLACEMENT SOLUTION – ISSUER SPONSOR APPROVAL

• Issuer approval of registered Sponsors and/or Designated Advisors

- JSE will load the first user per company with role "User Access Administrator" i.e. super user as you know it today
- Users will follow the new registration process and the authorised "User Access Administrator" will assign the required access roles
- Only users granted the user role "Issuer who can approve Sponsor Relationships" will be able to:
 - View and ATTEST or DISPUTE a linked Dedicated Sponsor/DA
 - Maintain Transaction Sponsor(s) as required
 - Ensure all contact details for enabled SENS users are correct as these details are linked back to the SENS user profile in the system

- 1. Displays your **username** that you used to log into the system.
- 2. Click the **LOGOUT** button to log out of the system.
- 3. Click the **HOME** button to return to the Dashboard.
- 4. Click the **CONTACT US** button to view the contact details of the JSE. The email address and telephone number are displayed. You can select to either contact the JSE, or SENS Office, for assistance.
- 5. Click the **HELP** button to view the SENS Online Help System, which contains comprehensive information on how to use the system.
- 6. The **MY TASK LIST** option opens by default when you log in to the system, displaying numerous Queues.
- 7. The Task List displays numerous queues, which reflect the **process flow** that an Announcement goes through from creation to dissemination. Each Queue displays the **number of Announcements** currently in that status. Click anywhere in the Queue row to expand or collapse the Queue.
- 8. The Main Menu displays different items. These Menu Items will vary depending on your User Profile, for example, a user with 'View Only access' cannot create an Announcement and as such the 'Create Announcement' menu item will not be displayed in the menu.
- 9. The REFRESH button is used to refresh the current Task List. It may take a few seconds for an Announcement to move from one Queue to the next. As such, you can click the Refresh button to view the updates more speedily.
