

June-Priority Incidents - All Markets/Services

P1 – 26 June – CDM-Halt of Commodities Market Root Cause – Software defect in the release deployed on

24/06 which included a new process for ASCII rotation (reseeding) of the alpha-numeric exchange refence number

Solution – Change was reverted on 26 June

P2 – 5 June – EQM – CPX Trading Session Issue Description – CPX did not close as expected and Certain trades during CPX did not execute at Closing Price

Root Cause - Following the MIT release on 27 May the change introduced a bug in the environment which impacted the operation on Closing Price Cross (CPX) session. The change was specific to the implementation of IOC orders in the CPX session.

Solution – Change for IOC orders was reversed to address trades at incorrect levels. A fix was deployed to address the automated transit7ion of the CPX phase.







Company Financials as Structured Data – TO-BE Summary of Key Points

This is an optional value-add data product that, while complementary, is separate to the SENS service **and not a replacement of the SENS data products**

Data products made up of an initial metric set of 18 standard popular metrics and a full metrics set comprising all metrics in Financial Position, (ii) Income, (iii) Cash Flow and (iv) Change in Earnings financial statement sections

Initial metric set provided quickly and full set much later due to number of metrics and perceived time use case need

For now, just identifying and providing metrics. Subsequent iterations will provide mapping to IFRS XBRL taxonomy details

Data products made available in both CSV an XBRL formats - XBRL being an XML variant attuned to financial reporting

Internet accessible and cloud-based access and topic subscription lowers connection complexity, effort and costs.

Data products are in formative phase from 1 July for 3 months to allow potential clients to "see and touch" data without any binding commitment and fees








Calendar Spread matching with implied orders

Currently on the Equity Derivatives and Currency Derivatives market when a calendar spread matches against an implied order, where a roll is taking place, the legs on the calendar spread are not discounted.

To solution for this a new field 'multilegReportType' has been added to the Realtime clearing system (RTC) version 1.37

New fields for the Clearing fee have been included in RTC version 1.37.


The new fields will be available when RTC version 1.37 goes live, however the fields will not contain any data until the JSEC Clearing fee initiative goes live in 2024

SENS Replacement Project Update

- Service Hotline 069/2023 issued 24 May 2023
 - Coming out of the internal dress rehearsals conducted during Q1 2023 we have **concerns** around the **readiness of the overall solution** for the JSE production environment
 - We have **decided to not commence client testing** until we are satisfied that the new solution is fit for purpose.
 - The provisional implementation timeline for Q2 2023 therefore will be delayed
- The JSE teams are still busy with re-planning the outstanding project activities including client testing and deployment implementation we hope to be able to provide an update to the market soon
- We will in due course communicate the revised project timeline


SENS Announcement Types and SubTypes Updates

- A Service Hotline to be issued shortly in which we will provide **30 days notice to clients** of these changes coming into effect
 - These announcement types and subtypes changes will be visible via the Live real-time Regulatory News Gateway and will also be included in the SENS End-of-Day products
 - There is <u>no change</u> to the Live real-time or EOD message/record formats and fields, these are additional values in existing fields on announcements
 - NOTE: An updated version of the SENS NewsML Knowledge Item (xml file) will be published which will include the new announcement types and subtypes
 - In addition, we will provide a full extract of all available SENS Announcement Types/SubTypes as part of the updated specs




