Final Decision: the DRESS REHEARSAL was a success and the new software will be required for trading on Monday 28 June 2010

Please note the JSE Equity and Commodity Derivative markets will proceed with the new software, all participants are encouraged to start downloading the new software as soon as possible – the front end version that will be accessible on Monday is **1.0.0.24382**, all previous versions will no longer be accessible.

Due to the changes made in the software, the new version requires users to clear their configuration setups and create new default windows in order to accommodate the new Global Market and ensure the splits windows update. Some minor issues were identified with the silo auction process which will be resolved on the JSE side. ALL USERS ARE ENCOURAGED TO START DOWNLOADING THE NEW SOFTWARE AS SOON AS POSSIBLE TO AVOID ANY DELAYS CONNECTING TO THE DERIVATIVE MARKETS ON MONDAY MORNING.

The original roll out plan remains unchanged and will be as follows:

28th June: CDM: auctioning off of silo receipts will be activated (see notice A1229) from 11h30

29th June: GLOBAL MARKET: crude oil using the code WTIO will be accessible to both EDM and CDM members as from the 9h00

30th June: GLOBAL MARKET: gold and platinum referencing the CME Group will be accessible to both EDM and CDM members as from the 9h00

5th July: EDM: new billing methodology will be applied to all EOD transactions
