Examinations are held in Johannesburg (Sandton), Durban and Cape Town in the mornings of the dates advised. The times and venues will be advised to registered candidates in due course.

Registration and payment for the examinations opens from date hereof and closes on Monday, 1 November 2010 at 16h00 except for Taxation which closes on Monday 18th October 2010. Candidates will not be allowed access to the examination venues if they have not registered and paid by these dates. Unfortunately no late registrations will be entertained.

Registration for the 2nd Semester courses opens from date hereof and **Rules II lectures commence on Monday 20 September 2010**. Lectures held in Sandton Johannesburg and due to time constraints, no lectures for Rules I will be presented this semester. However updated lecture notes for Rules I are available and should demand warrant a two full day Rules I workshop this will be held on two Saturdays.
