Voluntary NUTRON upgrade available including details of the next mandatory test weekend

All users of the NUTRON front end are advised that a number of patches have been released to address various issues reported by users since the go live of the global market in June 2010. We recommend that these are downloaded and installed as soon as possible if users make use of the functionality affected. The list of items addressed:

Item No	Description
1	Grid index out of range when opening spread window and some option windows.
2	Sort order not saving on the futures window
3	Opening of multiple silo auction depth windows re-arranges the existing opened windows.
4	Default the sort order of expiries when opening the splits window.
5	Out of memory issue when opening the Global Market trading window
6	Silo Auction Bid window reflecting the correct principal list

In total 11 files are available for download on a voluntary basis. The files should be placed in the folder where the NUTRON front end is installed. To identify the location please select the "About" tab on the NUTRON toolbar and click the "About" option – this will allow you to select the Running Directory option which will open the location where the patch files need to be copied:
