Mandatory NUTRON Software Upgrade for Equity and Commodity Derivatives Markets – Monday 16 May 2011

The JSE is pleased to announce a <u>mandatory</u> update of the NUTRON trading front-end for go live on 16 May 2011 in order to address a number of enhancements and bug fixes.

The following CDM enhancements / fixes have been addressed in this release:

- 1. To clarify confusion surrounding the 3 different Position Views, their descriptions have been amended to the following
 - View Positions (Dealer level)
 - View Con Positions (Sub-account level)
 - View Consolidated Member Positions (Member/Client level)
- The ability to download files for more than one day has been added to the Print/Transfer functionality.
 The ability to create files for the present and previous day is allowed during normal trading hours, while
 the new functionality to select any other day is only available outside normal trading hours i.e.
 Download only period.
- 3. Various issues regarding the loading of new clients and editing of existing client information has been resolved which includes saving updated information like email addresses
