Application to register additional soya delivery points and update on the standard storage rate

The SOYA contract does not trade via a single reference point and so each registered delivery point is traded on par without any location differentials. For the next marketing season commencing 1 March 2012 and following the increase in soybean production, the JSE has received various requests to register additional delivery points from various approved silo operators.

The SOYA standard storage rate will be calculated as follows unless information provided through the current PwC audit suggests otherwise: The JSE will ensure the storage rate is finalized by the last business day in January, note that the PPI figure as published at the end of December will be referenced for storage rate adjustments.

The below list of delivery points are already registered for other products however all new product applications are required to provide the market 15 business days to comment. Due to the holiday season this period has been slightly extended and market participants have until Friday 7 January 2012 to provide their comments directly to Chris Sturgess in writing via email chriss@jse.co.za.
