Additional soya delivery points approved and standard storage rate published

As per notice A1534 and the request to register additional SOYA delivery points, no objections were received and so the below list will be registered to take effect as from 1 March 2012 when the new marketing season commences.

The SOYA standard storage rate based on the PPI figure as published end of December will increase to **56 cents per ton per day** applied to outstanding storage for product delivered in completion of a futures contract. Market participants are again reminded the SOYA marketing season was changed last year to run from 1 March 2012 through until 28 February 2013.

Please find below the additional delivery points that will be included for the SOYA contract bringing the total number of delivery points to 96.
